Stein interpolation for the real interpolation method

Abstract

We prove a complex formulation of the real interpolation method, showing that the real and complex interpolation methods are not inherently real or complex. Using this complex formulation, we prove Stein interpolation for the real interpolation method. We apply this theorem to interpolate weighted L^p -spaces and the sectoriality of closed operators with the real interpolation method.

1 Introduction

In [25] Stein proved a convexity principle for the interpolation of analytic operator families on L^p -spaces. An important special case of [25, Theorem 1] states that an analytic family of linear operators $\{T(z)\}_{z\in\overline{\mathbb{S}}}$ which satisfies

$$||T(j+it)f||_{L^{p_j}(S)} \le M_j ||f||_{L^{q_j}(S)}, \quad t \in \mathbb{R}, j = 0, 1$$

for any simple function f and $p_0, p_1, q_0, q_1 \in [1, \infty]$ also satisfies

$$\|T(\theta)f\|_{L^p(S)} \leq M_0^{1-\theta} M_1^{\theta} \, \|f\|_{L^q(S)},$$

where $\theta \in (0, 1)$, $\frac{1}{p} = \frac{1-\theta}{p_0} + \frac{\theta}{p_1}$ and $\frac{1}{q} = \frac{1-\theta}{q_0} + \frac{\theta}{q_1}$. After the development of the complex interpolation method by Calderón [4], this theorem was generalized to general interpolation couples of (quasi)-Banach spaces, see e.g. [6, 8, 28]. In [26] Stein interpolation was proved for the so-called γ -interpolation method, using the complex formulation of the γ -interpolation method in [17].

The main goal of this paper is to develop Stein interpolation for the real interpolation method. Since Stein interpolation is inherently tied to complex function theory, this requires a complex formulation of the real interpolation method. In [5, 22] Cwikel and Peetre developed a real formulation of the complex interpolation method modelled after the Lions–Peetre mean method for real interpolation [20]. Our first main result is a complex formulation of the Lions–Peetre mean method. Combined with the result of Cwikel and Peetre this shows that the real and complex interpolation methods are not inherently real or complex. These interpolation methods are rather living on opposite sides of the Fourier transform. In [19] we push this viewpoint further by introducing an abstract framework, containing the real and complex interpolation methods and which has both a real and a complex formulation.

To state the complex formulation of the Lions-Peetre mean method, define the strip

$$S := \{ z \in \mathbb{C} : 0 < \text{Re}(z) < 1 \}.$$

For a Banach space X let $\mathscr{H}(\overline{\mathbb{S}};X)$ be the space of all continuous functions $f: \overline{\mathbb{S}} \to X$ which are analytic on \mathbb{S} and let $\mathscr{H}^1(\overline{\mathbb{S}};X)$ be the subspace of all $f \in \mathscr{H}(\overline{\mathbb{S}};X)$ which satisfy

$$\sup_{s\in[0,1]}\|t\mapsto f(s+it)\|_{L^1(\mathbb{R};X)}<\infty.$$

For $f \in \mathcal{H}^1(\overline{\mathbb{S}}; X)$ we define

$$f_j(t) := f(j+it), \quad t \in \mathbb{R}, \, j=0,1.$$

For $g \in L^1(\mathbb{R}; X)$ we use the Fourier transform and its inverse

$$\widehat{g}(\xi) := \int_{\mathbb{R}} g(t)e^{-it\xi}dt, \quad \check{g}(t) := \int_{\mathbb{R}} g(\xi)e^{it\xi}d\xi,$$

which yields a factor 2π in the Fourier inversion formula. For an interpolation couple of Banach spaces (X_0, X_1) , $\theta \in (0, 1)$ and $p \in [1, \infty]$ we denote the real interpolation spaces by $(X_0, X_1)_{\theta, p}$ (see Sect. 2 for definitions). By $\lesssim_{a,b,...}$ we mean that there is a constant C > 0 depending on a, b, ... such that inequality holds.

Theorem 1.1 Let (X_0, X_1) be an interpolation couple of Banach spaces, let $p_0, p_1 \in [1, \infty]$ and let $\theta \in (0, 1)$. Set $\frac{1}{p} = \frac{1-\theta}{p_0} + \frac{\theta}{p_1}$ and define

$$\|x\|_{\left(X_{0},X_{1}\right)_{\theta,p_{0},p_{1}}}^{(c)}:=\inf\max_{j=0,1}\ \left\|\widehat{f_{j}}\right\|_{L^{p_{j}}\left(\mathbb{R};X_{j}\right)},\quad x\in X_{0}+X_{1},$$

where the infimum is taken over all $f \in \mathcal{H}^1(\overline{\mathbb{S}}; X_0 + X_1)$ with $f(\theta) = x$. Then we have

$$\begin{split} \|x\|_{\left(X_{0},X_{1}\right)_{\theta,p}} &\lesssim_{\theta} \|x\|_{\left(X_{0},X_{1}\right)_{\theta,p_{0},p_{1}}}^{(c)}, \quad x \in X_{0} + X_{1}, \\ \|x\|_{\left(X_{0},X_{1}\right)_{\theta,p}} &\gtrsim_{\theta} \|x\|_{\left(X_{0},X_{1}\right)_{\theta,p_{0},p_{1}}}^{(c)}, \quad x \in X_{0} \cap X_{1}. \end{split}$$

Theorem 1.1 is a direct consequence of Theorem 3.2 and the equivalence of the real and Lions-Peetre mean methods. Note that it only yields an equivalent norm for $x \in X_0 \cap X_1$. One can not directly extend this to all $x \in (X_0, X_1)_{\theta,p}$ using density, since

$$(X_0,X_1)_{\theta,p_0,p_1}^{(\mathrm{c})} := \left\{ x \in X_0 + X_1 \, : \, \|x\|_{(X_0,X_1)_{\theta,p_0,p_1}}^{(\mathrm{c})} < \infty \right\}$$

is not a Banach space. One can circumvent this issue by considering appropriate spaces of distributions, which is further explored in [19, Section 4]. In applications the norm equivalence for $x \in X_0 \cap X_1$ usually suffices, avoiding the additional technicalities that distribution theory brings.

The idea to use analytic functions for the real interpolation method is not new. Implicitly it goes back to the work of Lions and Peetre [20, Section 1.4] (see also [21]). An elementary version of Theorem 1.1 was used by Zafran [29] to study the spectrum of bounded linear operators on interpolation spaces (cf. [29, Lemma 2.2] and Proposition 3.1 below). Moreover Cwikel, Kalton, Milman and Rochberg [7] build a unified theory for a class of interpolation methods, containing the real interpolation method, in which they systematically use analytic functions to prove commutator estimates.

Our complex formulation of the real interpolation method in Theorem 1.1 is analogous to the formulation of the complex interpolation method, which enables us to prove the announced version of Stein interpolation for the real interpolation method.

Theorem 1.2 Let (X_0, X_1) and (Y_0, Y_1) be interpolation couples of Banach spaces and let \check{X} be a dense subspace of $X_0 \cap X_1$. Let $p_0, p_1, q_0, q_1 \in [1, \infty]$, set

$$\frac{1}{p} = \frac{1-\theta}{p_0} + \frac{\theta}{p_1}, \quad \frac{1}{q} = \frac{1-\theta}{q_0} + \frac{\theta}{q_1},$$

and suppose $p < \infty$. Let $\{T(z)\}_{z \in \overline{\mathbb{S}}}$ be a family of linear operators from X to $Y_0 + Y_1$ such that

- (i) $T(\cdot)x \in \mathcal{H}(\overline{\mathbb{S}}; Y_0 + Y_1)$ for all $x \in \check{X}$.
- (ii) $T_j x := T(j+i\cdot)x \in L^{\infty}(\mathbb{R}; Y_j)$ for all $x \in \check{X}$ and

$$\left\|\left(T_{j}\widehat{f}\right)^{\vee}\right\|_{L^{q_{j}}\left(\mathbb{R};Y_{j}\right)}\leq M_{j}\left\|f\right\|_{L^{p_{j}}\left(\mathbb{R};X_{j}\right)},\quad f\in C_{c}^{\infty}(\mathbb{R})\otimes\check{X}.$$

for some $M_j > 0$ and j = 0, 1.

Then $T(\theta)$ is bounded from $(X_0, X_1)_{\theta,p}$ to $(Y_0, Y_1)_{\theta,q}$ for any $\theta \in (0, 1)$ with

$$||T(\theta)||_{\left(X_0,X_1\right)_{\theta,p}\to\left(Y_0,Y_1\right)_{\theta,q}}\lesssim_{\theta}M_0^{1-\theta}M_1^{\theta}.$$

Theorem 1.2 is a direct consequence of Theorem 4.1, the equivalence of the real and Lions-Peetre mean methods and the density of $X_0 \cap X_1$ in $(X_0, X_1)_{\theta,p}$ when $p < \infty$. Assumption (ii) in Theorem 1.2 is a Fourier multiplier condition, whereas the corresponding assumption in Stein interpolation for the complex interpolation method can be seen as a pointwise multiplier condition. This difference is due to the previously observed fact that the real and complex interpolation methods live on opposite sides of the Fourier transform.

The Fourier multiplier condition (ii) in Theorem 1.2 can in various situation be reduced to a simpler condition on m. Indeed, let $1 \le p \le q \le \infty$. For $m : \mathbb{R} \to \mathcal{L}(X,Y)$ one has

$$\left\|\left(m\widehat{f}\right)^{\vee}\right\|_{L^{q}(\mathbb{R};Y)}\lesssim \|f\|_{L^{p}(\mathbb{R};X)},\quad f\in L^{p}(\mathbb{R};X),$$

under either of the following conditions:

• Smoothness: p = q and $m \in C^2(\mathbb{R}; \mathcal{L}(X, Y))$ with for some $\varepsilon > 0$

$$\left\| \frac{\mathrm{d}^n}{\mathrm{d}t^n} m(\xi) \right\|_{\mathcal{L}(X,Y)} \lesssim \frac{1}{1 + |\xi|^{n+\varepsilon}} \quad \xi \in \mathbb{R}, \ n = 0, 1, 2,$$

since in this case $\check{m} \in L^1(\mathbb{R}; \mathcal{L}(X,Y))$ (see [1, Corollary 4.4]). Note that if T_j in Theorem 1.2 is of polynomial growth at infinity, the assumed decay is easily obtained by multiplying T(z) with $e^{(z-\theta)^2}$.

• Banach space geometry: X has Fourier type p and Y has Fourier type q' and $m: \mathbb{R} \to \mathcal{L}(X,Y)$ is strongly measurable in the strong operator topology with $\xi \mapsto \|m(\xi)\|_{\mathcal{L}(X,Y)} \in L^r(\mathbb{R})$ for $\frac{1}{r} = \frac{1}{p} - \frac{1}{q}$, see [24, Proposition 3.9]. One can weaken the assumption on m to the weak space $L^{r,\infty}(\mathbb{R})$ under a Fourier type $p_0 > p$ assumption on X and a Fourier type $q_0 < q'$ assumption on Y, see [24, Theorem 3.12]. Further results under type and cotype, rather than Fourier type, can also be found in [24].

We will give two applications of Theorem 1.2. Firstly we will deduce interpolation for weighted, vector-valued L^p -spaces from the unweighted case in Proposition 5.1, for which the Fourier multiplier condition can be checked using Fubini's theorem. Secondly we will interpolate the angle of $(\mathcal{R}$ -)sectorial operators in Proposition 5.2, for which the Fourier multiplier condition can be checked using a simpler version of the smoothness condition noted above. As a consequence we will improve a result of Fackler [10] on the interpolation of $(\mathcal{R}$ -)analytic semigroups.

This article is organized as follows: In Sect. 2 we prove some preliminary approximation results for the Lions–Peetre mean method. In Sect. 3 we will give a complex formulation of the Lions–Peetre interpolation method and in Sect. 4 we will prove Stein interpolation for the Lions–Peetre interpolation method. Finally, in Sect. 5, we will deduce the announced applications.



2 The Lions-Peetre mean method

For a general background on interpolation theory we refer to [3, 18, 27]. For an interpolation couple of Banach spaces (X_0, X_1) , t > 0 and $x \in X_0 + X_1$ the *K*-functional is given by

$$K(t, x, X_0, X_1) = \inf \left\{ \|x_0\|_{X_0} + t \|x_1\|_{X_1} : x = x_0 + x_1 \right\}$$

and for $\theta \in (0, 1)$ and $p \in [1, \infty]$ the real interpolation space $(X_0, X_1)_{\theta, p}$ is given as all $x \in X_0 + X_1$ such that

$$\|x\|_{\left(X_0,X_1\right)_{\theta,p}}:=\left\|t\mapsto t^{-\theta}K\left(t,x,X_0,X_1\right)\right\|_{L^p\left(\mathbb{R},\frac{\mathrm{d}t}{t}\right)}<\infty.$$

In [20] Lions and Peetre introduced their mean methods. For $p_0, p_1 \in [1, \infty]$ they defined $(X_0, X_1)_{\theta, p_0, p_1}$ as the space of all $x \in X_0 + X_1$ such that

$$||x||_{(X_0,X_1)_{\theta,p_0,p_1}} := \inf \max_{j=0,1} ||t \mapsto e^{t(j-\theta)} f(t)||_{L^{p_j}(\mathbb{R};X_j)} < \infty,$$

where the infimum is taken over all strongly measurable $f: \mathbb{R} \to X_0 \cap X_1$ with $\int_{\mathbb{R}} f(t) dt = x$. Note that $\int_{\mathbb{R}} f(t) dt$ converges as a Bochner integral in $X_0 + X_1$ by the L^{p_i} -bounds. Lions and Peetre showed that

$$(X_0, X_1)_{\theta,p} = (X_0, X_1)_{\theta,p_0,p_1}$$

isomorphically when $\frac{1}{p} = \frac{1-\theta}{p_0} + \frac{\theta}{p_1}$, so the Lions–Peetre mean method is a reformulation of the real interpolation method.

In the upcoming sections we will need to be able to restrict to smooth functions in the definition of the Lions–Peetre mean method, for which we will prove the following lemma. For a Banach space X we denote the X-valued Schwartz functions by $\mathcal{S}(\mathbb{R};X)$.

Lemma 2.1 Let (X_0, X_1) be an interpolation couple of Banach spaces, let $p_0, p_1 \in [1, \infty]$ and let $\theta \in (0, 1)$.

(i) For $x \in X_0 + X_1$ we have

$$||x||_{(X_0,X_1)_{\theta,p_0,p_1}} \approx \inf \max_{j=0,1} ||t \mapsto e^{t(j-\theta)} f(t)||_{L^{p_j}(\mathbb{R};X_j)},$$

where the infimum is taken over $f \in \mathcal{S}(\mathbb{R}; X_0 + X_1)$ with $\int_{\mathbb{R}} f(t) dt = x$.

(ii) Let \check{X} be a dense subset of $X_0 \cap X_1$. For $x \in \check{X}$ we have

$$||x||_{(X_0,X_1)_{\theta,p_0,p_1}} \approx_{\theta} \inf \max_{j=0,1} ||t \mapsto e^{t(j-\theta)} f(t)||_{L^{p_j}(\mathbb{R};X_j)},$$

where the infimum is taken over $f \in C_c^{\infty}(\mathbb{R}) \otimes \check{X}$ with $\int_{\mathbb{R}} f(t) dt = x$.

Proof The inequality " \leq " follows in both cases directly from the definition of the Lions-Peetre mean method. Take $x \in (X_0, X_1)_{\theta, p_0, p_1}$ of norm one and let $f: \mathbb{R} \to X_0 \cap X_1$ be strongly measurable such that $\int_{\mathbb{R}} f(t) \mathrm{d}t = x$ and

$$\max_{j=0,1} \left\| t \mapsto e^{t(j-\theta)} f(t) \right\|_{L^{p_j}(\mathbb{R};X_j)} \le 2.$$

For (i) define

$$x_k := \int_k^{k+1} f(t) dt, \quad k \in \mathbb{Z}$$

and let $\varphi \in C_c^{\infty}(\mathbb{R})$ with $\int_{\mathbb{R}} \varphi(t) dt = 1$, supp $\varphi \subseteq [0, 1]$ and $\|\varphi\|_{L^{\infty}(\mathbb{R})} \le 2$. Setting

$$\widetilde{f}(t) := \sum_{k \in \mathbb{Z}} x_k \otimes \varphi(t - k), \quad t \in \mathbb{R},$$

we have

$$\max_{j=0,1} \ \left\| t \mapsto \mathrm{e}^{t(j-\theta)} \widetilde{f}(t) \right\|_{L^{p_j}(\mathbb{R};X_j)} \lesssim \max_{j=0,1} \ \left\| t \mapsto \mathrm{e}^{t(j-\theta)} f(t) \right\|_{L^{p_j}(\mathbb{R};X_j)} \leq 2$$

and $\int_{\mathbb{R}} \widetilde{f}(t) dt = x$. Moreover

$$||x_k||_{X_0+X_1} \lesssim \min\{e^{k\theta}, e^{-k(1-\theta)}\}, \quad k \in \mathbb{Z},$$

so $\widetilde{f} \in \mathscr{S}(\mathbb{R}; X_0 + X_1)$, which proves (i).

For (ii) assume additionally that we have $x \in \check{X}$. Take $n \in \mathbb{N}$ such that $||x||_{X_0 \cap X_1} \le n$ and define

$$y_+ := \int_{0}^{\infty} f(t)dt = x - \int_{-\infty}^{n} f(t)dt$$

By Hölder's inequality we have

$$\begin{split} & \big\| y_+ \big\|_{X_0} \leq \|x\|_{X_0} + \int_{-\infty}^n \|f(t)\|_{X_0} \mathrm{d}t \leq n + \frac{2}{(\theta p_0')^{1/p_0'}} \cdot \mathrm{e}^{n\theta} \leq n + \frac{2}{\theta} \cdot \mathrm{e}^{n\theta} \\ & \big\| y_+ \big\|_{X_1} \leq \int_n^\infty \|f(t)\|_{X_1} \mathrm{d}t \leq \frac{1}{((1-\theta)p_1')^{1/p_1'}} \cdot \mathrm{e}^{-n(1-\theta)} \leq \frac{1}{1-\theta} \cdot \mathrm{e}^{-n(1-\theta)}. \end{split}$$

so in particular $y_+ \in X_0 \cap X_1$. Therefore, $g_+ := \mathbf{1}_{[n-1,n]} \otimes y_+$ satisfies

$$\max_{j=0,1} \ \left\| t \mapsto \mathrm{e}^{t(j-\theta)} g_+(t) \right\|_{L^{p_j}(\mathbb{R};X_i)} \lesssim_\theta 1.$$

Analogously, $g_- := \mathbf{1}_{[-n,-n+1]} \otimes \int_{-\infty}^{-n} f(t) dt$ satisfies the same estimate, so defining $g := f \mathbf{1}_{[-n,n]} + g_+ + g_-$ we have $\int_{\mathbb{R}} g(t) dt = x$ and

$$\max_{i=0,1} \left\| t \mapsto e^{t(j-\theta)} g(t) \right\|_{L^{p_j}(\mathbb{R};X_i)} \lesssim_{\theta} 1.$$

Similar to the proof of (i) define

$$y_k := \int_k^{k+1} g(t) dt, \quad -n \le k \le n-1$$

and set

$$\widetilde{g}(t) := \sum_{k=-n}^{n-1} y_k \otimes \varphi(t-k), \quad t \in \mathbb{R}.$$

As before we have

$$\left\|t\mapsto \mathrm{e}^{t(j-\theta)}\widetilde{g}(t)\right\|_{L^{p_j}(\mathbb{R};X_j)}\lesssim \max_{j=0,1}\left\|t\mapsto \mathrm{e}^{t(j-\theta)}g(t)\right\|_{L^{p_j}(\mathbb{R};X_j)}\lesssim_{\theta} 1.$$

Let $(z_k)_{k=-n}^{n-1} \subseteq \check{X}$ be such that $||y_k - z_k||_{X_0 \cap X_1} \le e^{-n}$ and define

$$\widetilde{h}(t) := \sum_{k=-n}^{n-1} z_k \otimes \varphi(t-k), \quad t \in \mathbb{R}$$

with φ as before. Then we have

$$z := \sum_{k=-n}^{n-1} y_k - z_k = x - \sum_{k=-n}^{n-1} z_k \in \check{X},$$

so $h:=\widetilde{h}+\varphi\otimes z$ is a function in $C_c^\infty(\mathbb{R})\otimes \widecheck{X}$ and $\int_{\mathbb{R}}h(t)\mathrm{d}t=x$. Moreover, since $\left\|\widetilde{g}-\widetilde{h}\right\|_{L^\infty(\mathbb{R};X_0\cap X_1)}\leq 2\mathrm{e}^{-n}$ and $\|z\|_{X_0\cap X_1}\leq 1$ by construction, we have

$$\max_{j=0,1} \ \left\| t \mapsto \mathrm{e}^{t(j-\theta)} h(t) \right\|_{L^{p_j}(\mathbb{R};X_j)} \lesssim_\theta 1$$

which finishes the proof.

3 A complex formulation of the Lion-Peetre mean method

We now turn to the complex formulation of the Lions–Peetre mean method, and thus of the real interpolation method. Let X be a Banach space. In addition to the spaces $\mathscr{H}(\overline{\mathbb{S}};X)$ and $\mathscr{H}^1(\overline{\mathbb{S}};X)$ defined in the introduction, we will use spaces of holomorphic functions which are not necessarily continuous on the boundary. Let $\mathscr{H}(\mathbb{S};X)$ be the space of all analytic functions $f:\mathbb{S}\to X$ and let $\mathscr{H}^1(\mathbb{S};X)$ be the subspace of all $f\in\mathscr{H}(\mathbb{S};X)$ which satisfy

$$\sup_{s\in(0,1)}\|t\mapsto f(s+it)\|_{L^1(\mathbb{R};X)}<\infty.$$

For $f \in \mathcal{H}(\mathbb{S}; X)$ we define

$$f_s(t) := f(s+it), \quad t \in \mathbb{R}, s \in (0,1)$$

and for $f \in \mathcal{H}^1(\mathbb{S}; X)$ the limits $f_j := \lim_{s \to j} f_s$ exist in $L^1(\mathbb{R}; X)$ (see e.g. [2, 23]). Note that these limits coincide with the pointwise limit if $f \in \mathcal{H}^1(\overline{\mathbb{S}}; X)$.

Our first complex formulation is a simple reformulation of the Lions-Peetre mean method using the Fourier transform of f_{θ} .

Proposition 3.1 Let (X_0, X_1) be an interpolation couple of Banach spaces, let $p_0, p_1 \in [1, \infty]$ and let $\theta \in (0, 1)$. For $x \in X_0 + X_1$ we have

$$||x||_{(X_0,X_1)_{\theta,p_0,p_1}} \approx \inf \max_{j=0,1} ||t \mapsto e^{t(j-\theta)} \hat{f}_{\theta}(t)||_{L^{p_j}(\mathbb{R};X_j)},$$

where the infimum is taken over all $f \in \mathcal{H}(\mathbb{S}; X_0 + X_1)$ with $f(\theta) = x$ and $f_{\theta} \in L^1(\mathbb{R}; X_0 + X_1)$.

Proof First let $x \in X_0 + X_1$ be such that there is an $f \in \mathcal{H}(\mathbb{S}; X_0 + X_1)$ with $f(\theta) = x$, $f_{\theta} \in L^1(\mathbb{R}; X_0 + X_1)$ and

$$t\mapsto \mathrm{e}^{t(j-\theta)}\widehat{f}_{\theta}(t)\in L^{p_j}(\mathbb{R};X_j),\quad j=0,1.$$

Since $\hat{f}_{\theta} \in L^1(\mathbb{R}; X_0 + X_1)$ by Hölder's inequality, we have by Fourier inversion (see [14, Proposition 2.4.5])

$$\frac{1}{2\pi} \int_{\mathbb{D}} \widehat{f}_{\theta}(t) dt = f_{\theta}(0) = x$$

with convergence in $X_0 + X_1$. Thus using $g = \frac{\hat{f}_{\theta}}{2\pi}$ in the definition of the norm of $(X_0, X_1)_{\theta, p_0, p_1}$ we have

$$\|x\|_{(X_0,X_1)_{\theta,p_0,p_1}} \le \frac{1}{2\pi} \max_{j=0,1} \|t\mapsto \mathrm{e}^{t(j-\theta)} \widehat{f}_{\theta}(t)\|_{L^{p_j}(\mathbb{R};X_j)}.$$

Taking the infimum over all such f yields the inequality " \lesssim ".

Conversely take $x \in (X_0, X_1)_{\theta, p_0, p_1}$ and let $f \in \mathcal{S}(\mathbb{R}; X_0 + X_1)$ be such that $\int_{\mathbb{R}} f(t) dt = x$ and

$$t \mapsto e^{t(j-\theta)} f(t) \in L^{p_j}(\mathbb{R}; X_i), \quad j = 0, 1.$$

Then, using Hölder's inequality, we note that

$$g(z) := \int_{\mathbb{R}} f(t) e^{(z-\theta)t} dt, \quad z \in \mathbb{S}$$

is absolutely convergent in X_0+X_1 for any $z\in \mathbb{S}$ and thus $g\in \mathcal{H}(\mathbb{S};X_0+X_1)$. Moreover

$$g_\theta = 2\pi \check{f} \in \mathcal{S}(\mathbb{R}; X_0 + X_1) \subseteq L^1(\mathbb{R}; X_0 + X_1)$$

and $g(\theta) = x$. Taking the infimum over all such f yields the inequality " \gtrsim " by Lemma 2.1(i).

To reformulate Proposition 3.1 further in the spirit of the complex interpolation method, we will use that $t\mapsto \mathrm{e}^{t(j-\theta)}\widehat{f}_{\theta}(t)$ is independent of $\theta\in(0,1)$ for $f\in\mathcal{H}^1(\mathbb{S};X_0+X_1)$. Combined with the approximation in Lemma 2.1(ii) this yields our complex formulation of the Lions–Peetre mean method.

Theorem 3.2 Let (X_0, X_1) be an interpolation couple of Banach spaces, let $p_0, p_1 \in [1, \infty]$ and let $\theta \in (0, 1)$. We have

$$||x||_{(X_0,X_1)_{\theta,p_0,p_1}} \le \frac{1}{2\pi} \inf \max_{j=0,1} ||\widehat{f}_j||_{L^{p_j}(\mathbb{R};X_j)}, \quad x \in X_0 + X_1,$$

where the infimum is taken over all $f \in \mathcal{H}^1(\mathbb{S}; X_0 + X_1)$ with $f(\theta) = x$. Furthermore, if \check{X} is a dense subspace of $X_0 \cap X_1$, we have

$$\|x\|_{\left(X_0,X_1\right)_{\theta,p_0,p_1}}\gtrsim_{\theta}\inf\max_{j=0,1}\left\|\widehat{f_j}\right\|_{L^{p_j}(\mathbb{R};X_j)},\quad x\in \widecheck{X},$$

where the infimum is taken over all $f \in \mathcal{H}^1(\overline{\mathbb{S}}; X_0 + X_1)$ such that $f(\theta) = x$ and $(s,t) \mapsto \widehat{f}_s(t) \in C_c^{\infty}([0,1] \times \mathbb{R}) \otimes \widecheck{X}$.

Proof Let $x \in X_0 + X_1$ and take $f \in \mathcal{H}^1(\mathbb{S}; X_0 + X_1)$ such that $f(\theta) = x$. For $s \in (0, 1)$ and $n \in \mathbb{N}$ define

$$g_{s,n}(\xi) := \int_{-n}^{n} f(s+it) e^{-(s+it)\xi} dt, \quad \xi \in \mathbb{R}$$

and note that for $0 < s_1 < s_2 < 1$ we have by the Cauchy–Goursat theorem

$$g_{s_1,n}(\xi) - g_{s_2,n}(\xi) = \sum_{\epsilon = +1} \epsilon \int_{s_1}^{s_2} f(s + i\epsilon n) e^{-(s + i\epsilon n)\xi} ds, \quad \xi \in \mathbb{R}.$$

By [15, Lemma H.1.4] the right hand-side tends to zero for $n \to \infty$, so

$$e^{-s_1\xi}\widehat{f}_{s_1}(\xi) = e^{-s_2\xi}\widehat{f}_{s_2}(\xi), \quad \xi \in \mathbb{R}.$$

Using the L^1 -convergence of $f_s \to f_j$ for j = 0, 1, we deduce

$$\hat{f}_i(\xi) = e^{(j-\theta)\xi} \hat{f}_{\theta}(\xi), \quad \xi \in \mathbb{R}.$$

By Proposition 3.1 (and an inspection of the proof for the constant) this implies

$$||x||_{(X_0,X_1)_{\theta,p_0,p_1}} \le \frac{1}{2\pi} \max_{i=0,1} ||\widehat{f}_i||_{L^{p_i}(\mathbb{R};X_i)},$$

so taking the infimum over all such f yields the first claim.

For the second claim take $x \in \check{X}$ and let $g \in C_c^{\infty}(\mathbb{R}) \otimes \check{X}$ with $\int_{\mathbb{R}} g(t) dt = x$. For

$$f(z) := \int_{\mathbb{R}} e^{\tau(z-\theta)} g(\tau) d\tau, \quad z \in \overline{\mathbb{S}}$$

we have $f \in \mathcal{H}^1(\overline{\mathbb{S}}; X_0 + X_1)$, $f(\theta) = x$ and

$$(s,t)\mapsto \widehat{f}_s(t)\in C_c^\infty([0,1]\times\mathbb{R})\otimes \widecheck{X}.$$

Moreover $\hat{f}_i(t) = 2\pi e^{t(j-\theta)}g(t)$ for $t \in \mathbb{R}$ by Fourier inversion (see [14, Proposition 2.4.51), so

$$\max_{j=0,1} \left\| \widehat{f}_j \right\|_{L^{p_j}(\mathbb{R};X_j)} = 2\pi \max_{j=0,1} \left\| t \mapsto \mathrm{e}^{t(j-\theta)} g(t) \right\|_{L^{p_j}(\mathbb{R};X_j)}.$$

Taking the infimum over all such f proves the second claim by Lemma 2.1(ii).

Remark 3.3 As discussed in the introduction, Theorem 3.2 can be extended to a norm equivalence for all $x \in (X_0, X_1)_{\theta, p_0, p_1}$ using appropriate spaces of distributions, which will be further explored in [19].

4 Stein interpolation

Using the complex formulation from the previous section we can now prove Stein interpolation for the Lions-Peetre method, and thus for the real interpolation method.

Theorem 4.1 Let (X_0, X_1) and (Y_0, Y_1) be interpolation couples of Banach spaces and let \check{X} be a dense subspace of $X_0 \cap X_1$. Let $p_0, p_1, q_0, q_1 \in [1, \infty]$. Let $\{T(z)\}_{z \in \overline{\mathbb{S}}}$ be a family of linear operators from X to $Y_0 + Y_1$ such that

- $\begin{array}{ll} \text{(i)} & T(\cdot)x \in \mathscr{H}(\overline{\mathbb{S}}; Y_0 + Y_1) \, for \, all \, x \in \check{X}. \\ \text{(ii)} & T_j x := T(j+i\cdot)x \in L^\infty(\mathbb{R}; Y_j) \, for \, all \, x \in \check{X} \, and \end{array}$

$$\left\|\left(T_{j}\widehat{g}\right)^{\vee}\right\|_{L^{q_{j}}(\mathbb{R};Y_{i})} \leq M_{j} \|g\|_{L^{p_{j}}(\mathbb{R};X_{j})}, \quad g \in C_{c}^{\infty}(\mathbb{R}) \otimes \check{X}.$$

for some $M_i > 0$ and j = 0, 1.

Then we have $T(\theta)\ddot{X} \subseteq (Y_0, Y_1)_{\theta, q_0, q_1}$ for any $\theta \in (0, 1)$ with

$$\|T(\theta)x\|_{(Y_0,Y_1)_{\theta,q_0,q_1}} \lesssim_\theta M_0^{1-\theta} M_1^\theta \, \|x\|_{(X_0,X_1)_{\theta,p_0,p_1}}, \quad x \in \breve{X}.$$

Proof Let $x \in \check{X}$. By Theorem 3.2 we can find an $f \in \mathscr{H}^1(\overline{\mathbb{S}}; X_0 + X_1)$ such that $f(\theta) = x, (s, t) \mapsto \hat{f}_s(t) \in C_c^{\infty}([0, 1] \times \mathbb{R}) \otimes \check{X}$ and

$$\max_{j=0,1} \ \left\| \widehat{f}_j \right\|_{L^{p_j}(\mathbb{R};X_j)} \lesssim_{\theta} \|x\|_{(X_0,X_1)_{\theta,p_0,p_1}}.$$

Note that $f \in \mathcal{H}^1(\mathbb{S}) \otimes \check{X}$, so $h(z) := \left(\frac{M_0}{M_1}\right)^{z-\theta} T(z) f(z)$ is well-defined for $z \in \overline{\mathbb{S}}$. Then $h(\theta) = T(\theta) x$ and by assumptions (i), (ii) and Hadamard's three lines lemma we have $h \in \mathcal{H}^1(\overline{\mathbb{S}}; Y_0 + Y_1)$. Therefore, using assumption (ii) with $g = \frac{1}{2\pi} \check{f}_j$ and Theorem 3.2, we have

$$\begin{split} \|T_{\theta}x\|_{(Y_{0},Y_{1})_{\theta,q_{0},q_{1}}} &\leq \max_{j=0,1} \|\widehat{h}_{j}\|_{L^{q_{j}}(\mathbb{R};Y_{j})} \\ &= \max_{j=0,1} \left(\frac{M_{0}}{M_{1}}\right)^{j-\theta} \|\widehat{T_{j}f_{j}}\|_{L^{q_{j}}(\mathbb{R};Y_{j})} \\ &\leq \frac{1}{2\pi} \max_{j=0,1} \left(\frac{M_{0}}{M_{1}}\right)^{j-\theta} M_{j} \|\widehat{f}_{j}\|_{L^{p_{j}}(\mathbb{R};X_{j})} \\ &\lesssim_{\theta} M_{0}^{1-\theta}M_{1}^{\theta} \|x\|_{(X_{0},X_{1})_{\theta,p_{0},p_{1}}}, \end{split}$$

which finishes the proof.

Remark 4.2

- (i) When $(p_0, p_1) \neq (\infty, \infty)$ in Theorem 4.1, we can extend $T(\theta)$ to a bounded operator from $(X_0, X_1)_{\theta, p_0, p_1}$ to $(Y_0, Y_1)_{\theta, q_0, q_1}$ by density. For the case $(p_0, p_1) = (\infty, \infty)$ one could first extend the complex formulation to any $x \in (X_0, X_1)_{\theta, p_0, p_1}$ (see also Remark 3.3) to avoid a density argument.
- (ii) When $p_j = q_j$, the boundedness assumption on $T_j(\cdot)x$ in Theorem 4.1 follows from the assumption that T_j is an $L^{p_j}(\mathbb{R};X_j)$ -Fourier multiplier for j=0,1 (see [14, Theorem 5.3.15]). When $p_j \neq q_j$ one can have Fourier multipliers which are not bounded, see e.g. [13, 24]. One can relax the boundedness assumption on $T_j(\cdot)x$ in Theorem 4.1, as long as one ensures that $h \in \mathscr{H}^1(\mathbb{S};Y_0+Y_1)$ and $h_s \to h_j$ for $s \to j$ in $L^1(\mathbb{R};Y_0+Y_1)$ for j=0,1.
- (iii) The implicit constant in the conclusion of Theorem 4.1 is an artefact of the approximation in Lemma 2.1. One could circumvent this approximation by going to a suitable class of distributions rather than functions, which we leave to the interested reader.

5 Applications

As a first, simple application of Theorem 4.1, we will deduce the interpolation of weighted L^p -spaces under the real interpolation method from the unweighted case. For complex interpolation this argument is standard and for the γ -interpolation method this can be found in [26, Theorem 3.2], but for real interpolation one usually employs different arguments (see e.g. [18, Theorem IV.2.11]).

Let X be a Banach space and let (S, μ) be a measure space. A measurable function $w: S \to (0, \infty)$ is called a weight and for $p \in [1, \infty)$ we define $L^p_w(S; X)$ as the space of all $f \in L^0(S; X)$ such that $fw \in L^p(S; X)$ with norm

$$||f||_{L^p(S;X)} := ||fw||_{L^p(S;X)}.$$

Proposition 5.1 Let (X_0, X_1) be an interpolation couple of Banach spaces, let (S, μ) be a measure space and let $\theta \in (0, 1)$. Take $p_0, p_1 \in [1, \infty]$ with $(p_0, p_1) \neq (\infty, \infty)$ and let $w_0, w_1 : S \to (0, \infty)$ be weights. Set $\frac{1}{p} = \frac{1-\theta}{p_0} + \frac{\theta}{p_1}$ and let $w = w_0^{1-\theta} w_1^{\theta}$. Then we have

$$\Big(L^{p_0}_{w_0}\big(S;X_0\big),L^{p_1}_{w_1}\big(S;X_1\big)\Big)_{\theta,p}=L^p_w\Big(S;\big(X_0,X_1\big)_{\theta,p}\Big).$$

Proof Set $\check{X} := L_{w_0}^{p_0}(S; X_0) \cap L_{w_1}^{p_1}(S; X_1)$ and for $z \in \overline{S}$ define

$$T(z): \check{X} \to L^{p_0}(S; X_0) + L^{p_1}(S; X_1)$$

by

$$T(z)x(s) := w_0(s)^{1-z}w_1(s)^z \cdot x(s), \quad s \in S.$$

Then $T(\cdot)x \in \mathcal{H}(\overline{\mathbb{S}}; L^{p_0}(S; X_0) + L^{p_1}(S; X_1))$ is bounded for all $x \in \check{X}$. Using Fubini's theorem, we have for $f \in C_c^{\infty}(\mathbb{R}) \otimes \check{X}$

$$\begin{split} \left\| (T_j \widehat{f})^{\vee} \right\|_{L^{p_j}(\mathbb{R}; L^{p_j}(S; X_j))} &= \left\| (s, t) \mapsto f\left(t - \log\left(\frac{w_0(s)}{w_1(s)}\right), s\right) \right\|_{L^{p_j}_{w_j}\left(S; L^{p_j}(\mathbb{R}; X_j)\right)} \\ &= \left\| f \right\|_{L^{p_j}\left(\mathbb{R}; L^{p_j}_{w_j}(S; X_j)\right)} \end{split}$$

for j = 0, 1. Therefore, by Theorem 1.2,

$$T(\theta): \left(L^{p_0}_{w_0}(S; X_0), L^{p_1}_{w_1}(S; X_1)\right)_{\theta, p} \to \left(L^{p_0}(S; X_0), L^{p_1}(S; X_1)\right)_{\theta, p}$$

is bounded. Since it is clearly injective and

$$(L^{p_0}(S; X_0), L^{p_1}(S; X_1))_{\theta, p} = L^p(S; (X_0, X_1)_{\theta, p})$$

by [14, Theorem 2.2.10], this proves the embedding " \hookrightarrow ". The converse embedding is proven similarly.

In Proposition 5.1 we were able to check the Fourier multiplier assumption in Theorem 1.2 using Fubini's theorem. In general, one needs to use a Fourier multiplier theorem to check this assumption. One could for example use the operator-valued Mihlin multiplier theorem (see [14, Theorem 5.3.18]), but this leads to undesirable restrictions on the involved Banach spaces in applications. Fortunately, we can often use the flexibility in our choice for $\{T(z)\}_{z\in\overline{\mathbb{S}}}$ to simplify the Fourier multiplier assumption in Theorem 4.1 considerably for smooth T_j . As an example we will interpolate the angle of $(\mathcal{R}$ -)sectoriality of a $(\mathcal{R}$ -)sectorial operator using the real interpolation method, which for the complex interpolation method was done in [16,

Corollary 3.9]. This result will allow us to improve a result of Fackler [10] on the extrapolation of the analyticity of a semigroup on the real interpolation scale.

Let X be a Banach space, let A be a closed operator on X and for $\sigma \in (0, \infty)$ we define the sector

$$\Sigma_{\sigma} := \{ z \in \mathbb{C} \setminus \{0\} : |\arg(z)| < \sigma \}.$$

We say that A is sectorial if there is a $\sigma \in (0, \pi)$ such that

$$\sup_{z\in\mathbb{C}\setminus\overline{\Sigma}_{\sigma}}\|zR(z,A)\|<\infty,$$

and we denote the infimum over all such σ by $\omega(A)$. We say that A is \mathcal{R} -sectorial if there is a $\sigma \in (0, \pi)$ such that

$$\mathcal{R}(\{zR(z,A):z\in\mathbb{C}\setminus\overline{\Sigma}_{\sigma}\})<\infty,$$

where $\mathcal{R}(\Gamma)$ denotes the \mathcal{R} -bound of an operator family $\Gamma \subseteq \mathcal{L}(X)$ (see [15, Chapter 8]. We denote the infimum over all such σ by $\omega_{\mathcal{R}}(A)$. For an introduction to $(\mathcal{R}$ -) sectorial operators we refer to [15, Chapter 10] and the references therein.

Proposition 5.2 Let (X_0, X_1) be an interpolation couple of Banach spaces and $p \in [1, \infty)$. Let A_{θ} be a closed operator on $(X_0, X_1)_{\theta, p}$ for all $\theta \in [0, 1]$ such that the following consistency assumption is satisfied:

$$R(z, A_{\theta})x = R(z, A_{\theta'})x, \quad x \in X_0 \cap X_1, \ \theta, \theta' \in [0, 1], \ z \in \rho(A_{\theta}) \cap \rho(A_{\theta'}).$$

For $\theta \in (0, 1)$ we have:

(i) If A_0 and A_1 are sectorial, then A_θ is sectorial with

$$\omega(A_{\theta}) \le (1 - \theta)\omega(A_0) + \theta\omega(A_1).$$

(ii) If X_0 and X_1 have nontrivial type and A_0 and A_1 are \mathcal{R} -sectorial, then A_{θ} is \mathcal{R} -sectorial with

$$\omega_{\mathcal{R}}(A_{\theta}) \le (1 - \theta)\omega_{\mathcal{R}}(A_0) + \theta\omega_{\mathcal{R}}(A_1).$$

Proof Take $\omega(A_j) < \sigma_j < \pi$ for j = 0, 1 and let $\theta \in (0, 1)$. Fix s > 0 and for $z \in \overline{\mathbb{S}}$ define $T(z): X_0 \cap X_1 \to X_0 + X_1$ by

$$T(z)x := e^{(z-\theta)^2} \cdot se^{i(\sigma_0 + (\sigma_1 - \sigma_0)z)} R(se^{i(\sigma_0 + (\sigma_1 - \sigma_0)z)}, A_\theta)x.$$

By the consistency assumption and the analyticity of $zR(z,A_j)$ on X_j for j=0,1 we have $T(\cdot)x \in \mathcal{H}(\overline{S};X_0+X_1)$ for any $x \in X_0 \cap X_1$. Define

$$f_i(t) := se^{i(\sigma_0 + (\sigma_1 - \sigma_0)(j+it))}, \quad t \in \mathbb{R}, j = 0, 1.$$

Then we have for $n \in \{0, 1, 2\}$ and $t \in \mathbb{R}$

$$\left\| \frac{\mathrm{d}^n}{\mathrm{d}t^n} f_j(t) R(f_j(t), A_j) \right\|_{\mathcal{L}(X_j)} \le |\sigma_1 - \sigma_0|^n \sum_{k=0}^n \left\| f_j(t)^k R(f_j(t), A_j)^k \right\|_{\mathcal{L}(X_j)}$$

$$\le C_j$$

with $C_i > 0$ independent of s, t, σ_0, σ_1 . Therefore, setting

$$T_j(t) := e^{(j+it-\theta)^2} f_j(t) R(f_j(t), A_j), \quad t \in \mathbb{R},$$

we obtain

$$\left\|t\mapsto \frac{\mathrm{d}^n}{\mathrm{d}t^n}T_j(t)\right\|_{L^1\left(\mathbb{R};\mathcal{L}(X_j)\right)}\lesssim C_j\sum_{k=0}^n\int_{\mathbb{R}}|t|^k\mathrm{e}^{(j-\theta)^2-t^2}\mathrm{d}t\lesssim C_j.$$

Defining $k_i := \check{T}_i$, we have

$$\begin{split} \left\| k_j \right\|_{L^1(\mathbb{R}; \mathcal{L}(X_j))} &\leq \left\| t \mapsto \frac{1}{1 + t^2} \right\|_{L^1(\mathbb{R})} \left\| t \mapsto \left(1 + t^2 \right) k_j(t) \right\|_{L^{\infty}(\mathbb{R}; \mathcal{L}(X_j))} \\ &\lesssim \left\| T_j \right\|_{L^1(\mathbb{R}; \mathcal{L}(X_j))} + \left\| t \mapsto \frac{\mathrm{d}^2}{\mathrm{d}t^2} T_j(t) \right\|_{L^1(\mathbb{R}; \mathcal{L}(X_j))} \lesssim C_j. \end{split}$$

We conclude that $T_j, k_j \in L^1(\mathbb{R}; \mathcal{L}(X_j))$, so we have by Fourier inversion and Young's inequality for $f \in \mathcal{S}(\mathbb{R}; X_i)$

$$\left\| \left(T_j \widehat{f} \right)^{\vee} \right\|_{L^p(\mathbb{R};X_j)} = \left\| k_j * f \right\|_{L^p(\mathbb{R};X_j)} \lesssim C_j \| f \|_{L^p(\mathbb{R};X_j)}.$$

Thus, using the consistency assumption, we conclude that $\{T(z)\}_{z \in \overline{\mathbb{S}}}$ satisfies the assumptions of Theorem 1.2, so we deduce for $x \in X_0 \cap X_1$ that

$$\begin{split} \left\| s \mathrm{e}^{(1-\theta)\sigma_0 + \theta\sigma_1} \right) & R(s \mathrm{e}^{(1-\theta)\sigma_0 + \theta\sigma_1}, A_\theta) \right\|_{\left(X_0, X_1\right)_{\theta, p} \to \left(X_0, X_1\right)_{\theta, p}} \\ &= \| T(\theta) \|_{\left(X_0, X_1\right)_{\theta, p} \to \left(X_0, X_1\right)_{\theta, p}} \lesssim_{\theta} C_0^{1-\theta} C_1^{\theta}. \end{split}$$

An analogous statement holds when σ_j is replaced by $-\sigma_j$, so we conclude that A_θ is sectorial with

$$\omega(A_{\theta}) \le (1 - \theta)\sigma_0 + \theta\sigma_1.$$

Taking σ_j abitrary close to $\omega(A_j)$ for j = 0, 1 finishes the proof of (i).

For (ii) let X be a Banach space and let $(\varepsilon_n)_{n=1}^{\infty}$ be a sequence of independent Rademacher variables on a probability space (Ω, \mathbb{P}) . Let $\varepsilon(X)$ be the Banach space of sequences $(x_k)_{k=1}^{\infty}$ such that $\sum_{k=1}^{\infty} \varepsilon_k x_k$ converges in $L^2(\Omega; X)$, endowed with the norm

$$\left\| (x_n)_{k=1}^{\infty} \right\|_{\varepsilon(X)} := \left\| \sum_{k=1}^{\infty} \varepsilon_k x_k \right\|_{L^2(\Omega;X)}.$$

We note that a closed operator B on X is \mathcal{R} -sectorial if and only if

$$\widetilde{B}(x_k)_{k=1}^{\infty} := (Bx_k)_{k=1}^{\infty}$$

$$D(\widetilde{B}) := \{(x_k)_{k=1}^{\infty} \in \varepsilon(D(B))\}$$

defines a sectorial operator on $\varepsilon(X)$. Moreover we have $\omega_{\mathcal{R}}(B) = \omega(\widetilde{B})$. Therefore, (ii) follows from (i) and the isomorphism

$$(\varepsilon(X_0), \varepsilon(X_1))_{\theta,p} = \varepsilon((X_0, X_1)_{\theta,p}),$$

see [15, Proposition 6.3.1, Theorems 7.4.16 and 7.4.23].

Remark 5.3 In [12] Haak, Haase and Kunstmann interpolate the \mathcal{R} -sectoriality of A on X_0 with the \mathcal{R} -boundedness of $\{R(\lambda,A), \lambda > 0\}$ on X_1 . Using Stein interpolation for the complex interpolation method on the analytic operator family $\lambda^z R(\lambda,A)$, one obtains the \mathcal{R} -boundedness of

$$\{\lambda^{1-\theta}R(\lambda,A), \lambda > 0\}$$

on $[X_0, X_1]_{\theta}$. The conditions for Stein interpolation for the complex interpolation method, which are pointwise multiplier conditions, are easily checked using randomization (see [15, Proposition 6.1.11]). However, when one tries to apply Theorem 1.2 for the real interpolation method, the Fourier multiplier conditions turn λ^{it} into a translation operator. It is well known that the family of translation operators is not \mathcal{R} -bounded on $L^p(\mathbb{R};X)$ (see [15, Proposition 8.1.16]) and thus the argument fails for real interpolation. This provides some intuition on why the counterexample provided in [12, Example 6.13] works.

Let $(S(t))_{t\geq 0}$ be a semigroup of bounded operators on X. We say that $(S(t))_{t\geq 0}$ is a C_0 -semigroup if

$$\lim_{t \downarrow 0} \|S(t)x - x\|_X = 0, \quad x \in X.$$

We define the generator of a C_0 -semigroup $(S(t))_{t\geq 0}$ as the closed operator $Ax := \lim_{t\downarrow 0} \frac{S(t)x-x}{t}$ with as domain the set of all $x \in X$ for which this limit exists.

We say that $(S(t))_{t\geq 0}$ is analytic if for some $\sigma \in (0, \frac{\pi}{2})$ the function $t \mapsto S(t)x$ extends analytically to Σ_{σ} for all $x \in X$ and call supremum over such σ the angle of analyticity. We say that $(S(t))_{t\geq 0}$ is \mathcal{R} -analytic if it is analytic and there is a $\sigma' \in (0, \sigma]$ such that

$$\mathcal{R}\left(\left\{T(z)\,:\,z\in\Sigma_{\sigma},\;|z|\leq1\right\}\right)<\infty$$

and we call the supremum over such σ the angle of \mathcal{R} -analyticity. We say that $(S(t))_{t\geq 0}$ is a *bounded* $(\mathcal{R}$ -)analytic semigroup if it is $(\mathcal{R}$ -)analytic and $\{S(z): z\in \Sigma_{\sigma}\}$ is $(\mathcal{R}$ -)bounded for all σ smaller than the angle of $(\mathcal{R}$ -) analyticity.

It is well-known that a densely defined $(\mathcal{R}\text{-})$ sectorial operator A on a Banach space X with $\omega(A) < \frac{\pi}{2}$ generates a bounded $(\mathcal{R}\text{-})$ analytic C_0 -semigroup $(e^{-tA})_{t\geq 0}$ of angle $\frac{\pi}{2} - \omega(A)$ and vice versa that the negative generator of a bounded $(\mathcal{R}\text{-})$ analytic C_0 -semigroup is a densely defined $(\mathcal{R}\text{-})$ sectorial operator (see [9, Theorem 4.6] and [15, Proposition 10.3.3]). Therefore, Proposition 5.2 yields new information on $(\mathcal{R}\text{-})$ analytic semigroups on the real interpolation scale. In particular, we can quantify the angle of $(\mathcal{R}\text{-})$ analyticity in a result of Fackler [10] (see also [11]).

Corollary 5.4 Let (X_0, X_1) be an interpolation couple of Banach spaces and let $(S(t))_{t\geq 0}$ be a semigroup on $X_0 + X_1$ which leaves both X_1 and X_2 invariant. Fix $\theta \in (0, 1)$ and $p \in [1, \infty)$.

- (i) If $(S(t))_{t\geq 0}$ is an analytic C_0 -semigroup of angle $\sigma \in (0, \frac{\pi}{2})$ on X_0 and $\{S(t): t \in (0,1)\}$ is uniformly bounded on X_1 , then $(S(t))_{t\geq 0}$ is an analytic C_0 -semigroup of angle at least $(1-\theta)\sigma$ on $(X_0,X_1)_{\theta,p}$.
- (ii) If X_0 and X_1 have nontrivial type, $(S(t))_{t\geq 0}$ is a \mathcal{R} -analytic C_0 -semigroup of angle $\sigma \in (0, \frac{\pi}{2})$ on X_0 and $\{S(t) : t \in (0, 1)\}$ is \mathcal{R} -bounded on X_1 , then $(S(t))_{t\geq 0}$ is an \mathcal{R} -analytic C_0 -semigroup of angle at least $(1 \theta)\sigma$ on $(X_0, X_1)_{\theta,p}$.

Proof Take $\eta \in (\theta, 1)$ and set $Y_1 := (X_0, X_1)_{\eta,p}$. By [10, Theorem 3.3] we know that $(S(t))_{t \ge 0}$ is an analytic C_0 -semigroup on Y_1 . Let $\omega > 0$ be such that $\widetilde{S}(t) := \mathrm{e}^{-\omega t} S(t)$ is a bounded analytic C_0 -semigroup on both X_0 and Y_1 and note that the angles of analyticity of $(S(t))_{t \ge 0}$ and $(\widetilde{S}(t))_{t \ge 0}$ on both X_0 and Y_1 are equal. Let A_0 and A_1 be the generators of $(\widetilde{S}(t))_{t \ge 0}$ on X_0 and Y_1 respectively, which by [9, Theorem 4.6] are sectorial operators with

$$\omega(A_j) \le \frac{\pi}{2} - (1-j)\sigma, \quad j = 0, 1.$$

For $\theta' \in (0, 1)$ we note that $(\widetilde{S}(t))_{t \geq 0}$ is a C_0 -semigroup on $(X_0, Y_1)_{\theta', p}$ and we denote its generator by $A_{\theta'}$. Then $(A_{\theta'})_{\theta' \in [0,1]}$ satisfies the assumptions of Proposition 5.2, so we obtain that $A_{\theta'}$ is sectorial on $(X_0, Y_1)_{\theta', p}$ with

$$\omega\big(A_{\theta'}\big) \leq \frac{\pi}{2} - (1-\theta')\sigma$$

and thus by [9, Theorem 4.6] we know that $(\widetilde{S}(t))_{t\geq 0}$ is a bounded analytic C_0 -semi-group on $(X_0, Y_1)_{\theta',p}$ of angle at least $(1 - \theta')\sigma$. It follows that $(S(t))_{t\geq 0}$ is an analytic C_0 -semi-group on $(X_0, Y_1)_{\theta',p}$ of angle at least $(1 - \theta')\sigma$ and thus, using reiteration for real interpolation [3, Theorem 3.5.3] and taking η arbitrary close to 1, (i) follows. Moreover (ii) follows from (i) by a similar argument as the one we used for Proposition 5.2(ii).
