Asplund's 1928 architectural design for the Stockholm Public Library no longer effectively meets the spatial demands of the city's modern society.

# design assignment in which these result.

The design assignment regarding the Stockholm Public Library is to explore how to maximize the potential offered by its architecture and urban setting. The focus is on addressing the needs of contemporary society and preparing for future changes. This includes adapting to the digital shift in knowledge dissemination while acknowledging the enduring importance of books.

The design aims to create a space that is open, welcoming, and easily accessible, catering to both educational and leisure activities. A crucial aspect is the commitment to sustainability, recognizing the challenges faced collectively. The goal is to craft an environment that not only honors the library's rich history but also looks ahead, providing an environmentally conscious hub for the community.

#### **Process**

# **Method description**

To address the research questions and meet the design requirements, various research methods will be carried out.

#### Site visit:

At the start, we will conduct research at the site. Together with the studio we will visit Stockholm city. During this site visit we will pass time in the library to get acquainted with and learn about the building. Furthermore, we will investigate the urban context and visit other relevant projects of Asplund and his contemporaries.

#### 1:25 model:

Together with the studio we will carefully construct a 1:25 model of a selection of interior spaces of the Asplund library as completed in 1928. This will be subdivided into different smaller models that can be assembled to form a comprehensive understanding of the library's organization. The model will serve to reveal insights into the library's conception at that time and allow us to track changes over the years. Archive pictures of the library will be recreated through model photography, providing a basis for comparison with images taken from the exact same positions in the library in 2023.

#### Precedent studies:

In order to understand the context in which the Stockholm Public Library was designed, we will study several precedents of Asplund's oeuvre. By doing this we will get to know the concepts, methodologies and aesthetic, compositional and material considerations that defined his evolving architectural interests. It will also offer a deeper understanding of the social, political, cultural, and architectural milieu during Asplund's period as an architect. To conclude this research we will create one drawing that summarizes the essence of the project.

#### Room for a library:

To comprehend the library as a contemporary public building and a larger institution, we will investigate the various facets that define a modern library space. This exploration involves considerations such as scale, character, furnishings, and the potential relationship with the exterior. Through this investigation, we aim to clarify our position and approach to the broader task of designing an extension for the Stockholm Public Library.

#### Modern library:

Together with the studio we will investigate multiple modern public libraries. By conducting thorough research and precise documentation, we will delve into the thought processes that influenced the design of each of these libraries. This involves examining their context, understanding how their architecture engages with the public, and representing their respective functions. Consistent drawing and

documentation methods across all research groups will facilitate clear comparisons between the different case studies.

# Project Journal:

Parallel to the research and design phases, a project journal will be developed to document the entire process and provide space for reflection. This documentation will be instrumental in assessing the research and progress made throughout the graduation year. In addition to the project journal, collective and individual research findings will be compiled and documented in research books and an exhibition at the faculty.

1. What is the relation between your graduation (project) topic, the studio topic (if applicable), your master track (A,U,BT,LA,MBE), and your master programme (MSc AUBS)?
