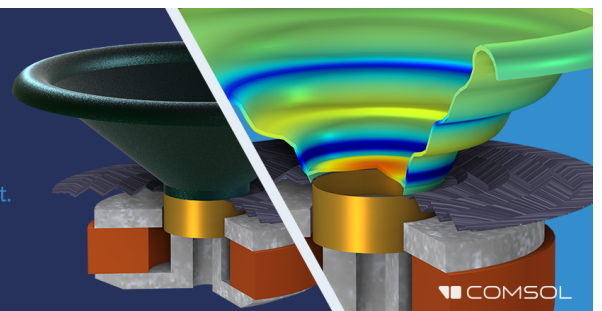

For the elastodynamic wave equation discussed in Appendix A.4 in Ref. 1, the expressions for matrices $\tilde{\mathbf{L}}_1^\pm$ and $\tilde{\mathbf{L}}_2^\pm$ in Eqs. (A32) and (A33) must be multiplied by ± 1 . In other words, the signs of $\tilde{\mathbf{L}}_1^-$ and $\tilde{\mathbf{L}}_2^-$ have to be changed, whereas the signs of $\tilde{\mathbf{L}}_1^+$ and $\tilde{\mathbf{L}}_2^+$ remain unchanged. With these corrections, matrix $\tilde{\mathbf{L}}$, defined in Eq. (A5), fulfills the

symmetry property formulated by Eq. (A6). The corrections have no consequences for Eqs. (A36)–(A38).
