The posed problem,	Currently due to the virtualization of the way of money and the role of the bank itself of money transactions being replaced, although the National Bank of Belgium has a huge space, it is difficult to play a role in the current society. In addition to this, this huge banking system not only embodies national capital but also alienates it from its urban context. In the future, the National Bank of Belgium will have fewer employees, how to use the extra space to make this building permeable and maintain it as a symbol of the National Bank? If the bank considers part to be open to the public, then who is the public? What will their arrival mean for banks and capital? Most importantly making architecture that is capable of addressing past, present, and future with both a sense of continuity and an openness to change.

design assignment in which these result.	Through processes of iterative drawing and physical and digital modeling, I need to develop a complex public building, resolved at all scales, from the interior to the urban. This is contextualized by understandings established in an integrated research program.  The design will propose means by which it could engage both the public and its own staff in this process of transformation: asking who they are, how they might be brought into relation with one another, and what types and qualities of space might successfully accommodate and engage them. Specifically, the current spatial organization of the bank is reconstructed through a series of drawings and models, and a new feasible layout plan is proposed. For the current structure and environmental factors of the building, feasible renovation measures are proposed. In addition to this, how the interior space is expressed to reflect the connection between the bank and the public / surrounding buildings / nature.

## **Process**

## **Method description**

Several research themes and methods have been explored, to focus on the NBB in Brussels from various perspectives.

#### **Precedent studies:**

The task will be to recreate these photographs as three-dimensional models and then record them in a way that recreates the original image. To be successful this will require extensive analysis of the drawings alongside the image. Its intention is to focus attention on the spatial and experiential character of the studied buildings and the ways in which they are inhabited, as a means for critique.

#### Literature research:

The purpose of the literature research is to have a basic understanding and objective evaluation method of the workspace and banking system in different eras through the research on banks and office spaces by architects and historians in different periods. These articles serve as a starting point to consider the connection between the NBB's workspace and the banking system and to critically present research and design perspectives.

## **Design: Social Plinth**

Thinking about the meaning and value of social base through design or behavior, as a means of thinking about public space. The approach might engage more or less directly with issues that pertain to what the bank does, or it might relate to questions that will form the context within which a future bank should operate or which it should be working to protect.

### Site research:

Site study through visiting the important buildings and surrounding areas near the site. Understanding the national bank from the Brussels' point of view, how it relate to the city and what its different facades represent. After walking around the city, a preliminary understanding of the landmarks and regional features of the variable region can be had. Besides, Through site research, there is a clearer understanding of the scope of urban space and the different representative elements: natural elements, churches, transportation, bank interior space and its needs, etc.

## Reflection

1. What is the relation between your graduation (project) topic, the studio topic (if applicable), your master track (A,U,BT,LA,MBE), and your master programme (MSc AUBS)?
