## **Process**

#### **Method description**

The following research is an exploratory research and will be done through a case study of a manufacturing company that owns a real estate portfolio. The research methods include gathering data through document analysis, site visits and interviews. The method is divided into three parts: document gather on sustainability and reporting from the European Commission, document gather from the company on their portfolio and data collection possibilities and data gather based on interviews with company employees and visits of production sites. The following step is the analysis of the gathered data. The analysis is also divided into three parts: early data analysis, exploration and description and finally explanation and prediction. Lastly, conclusions will be drawn and possible solutions to approach sustainability reporting will be proposed.

### Literature and general practical references

For this research I have done an extended literature research on the following topics: corporate real estate in manufacturing industry, sustainability in corporate real estate, sustainability reporting, EU regulations on sustainability and corporate real estate strategies. I will continue the literature research after P2, especially documents on sustainability reporting published by the EU. As part of my market research I have interviewed 4 practitioners mostly related to sustainability and sustainability reporting. In the research part I will conduct a case study in an organization: a manufacturing company that owns a real estate portfolio.
