The housing situation in the Netherlands is the main topic of discussion of our graduation studio in the context of the Dutch government's decision to build one million homes by 2030, mainly by densifying big cities.

Groot IJsselmonde, is an example of a neighborhood that was built to low standards due to circumstances. The period it was constructed in, after the second world war, brought an urgent need for cheap housing projects

In my perspective, the general problem is composed of three main aspects: architectural, sociological, and economical. In my research I discovered that the economic aspect is the connecting part between architecture and society. Architecturally, it manifests itself in the quality of the building and its maintenance, and socially in the characteristics of the population.

In my design I am working in three main scales, the unit, the building, and group of buildings. In each of them I provide spaces that are undefined, following the theory of Bernard Tschumi. These spaces are meant to encourage self-expression among the residents. I believe that through self-expression in public spaces, lies the solution for social connection with neighbors. And through that, a greater sense of belonging that directly influences satisfaction of the residents.

Process

Method description

The research process has begun with a collaboration between the graduation studio`s participants. We gathered the general data about three main topics- the housing crisis in the Netherlands, post war neighborhoods, and different target groups that are relevant to housing projects. After this phase, I continued individually to research and collect information mainly to enrich my knowledge of the context. I am using plan analysis and flows mappings, to understand how people use the space and in the current state of the built environment, while developing a master plan for the area. I use gap analysis to understand what steps I need to take in order to achieve a residential project that will increase the sense of community between current residents and future ones. I plan on continuing developing by using mainly the method research by design, in order to test concepts in floorplans and volumetric studies in order to achieve the best spatial solution possible.

Reflection

1. What is the relation between your graduation (project) topic, the studio topic (if applicable), your master track (A,U,BT,LA,MBE), and your master programme (MSc AUBS)?
